

French Bull Dog Club of America Application for Membership

The membership application process consists of several steps. They are:

1. Complete the application below being certain to answer ALL questions.
2. Have two (2) current FBDCA members complete, sign, and ***mail the FBDCA Sponsor Form for New Member Applications to you.*** Once received, attach both signed sponsorship forms to your membership application.
3. Sign, date and attach the FBDCA Code of Ethics to your membership application.
4. Submit a check or money order for \$25 made out to “French Bull Dog Club of America” for each membership application.

Each person applying for membership must complete the application, attach their signed Code of Ethics, attach two (2) signed FBDCA Sponsor Form for New Member, and a valid check or money order in the amount of \$25 for the first year’s membership dues.

A complete application for membership packet consists of four (4) documents and a \$25 check or money order.

Letters and comments submitted by members will be reviewed by the Board prior to voting on your application. You will be notified of the results.
