

## **French Bull Dog Club of America**

### **Application for Membership**

Our application process takes time and it is expected to detail the part Frenchies play in the daily life of the applicant. The membership application process consists of several steps. A complete application for membership packet consists of four (4) documents and two (2) checks or money orders as follows:

1. Complete the application being certain to answer all questions with completely.
2. Two (2) current FBDCA members are required to sponsor each applicant. Sponsors complete, sign, and ***mail the FBDCA Sponsor Form for New Member Applications to you.*** Once received, attach both signed sponsorship forms to your membership application.
3. Sign, date and attach the FBDCA Code of Ethics to your membership application.
4. Submit two (2) checks or money orders – one for \$25.00 annual dues and another for \$25.00 application non-refundable processing fee, made out to “French Bull Dog Club of America” for each membership application.

Each applicant must have two sponsors who are FBDCA members in good standing. Each sponsor must know the applicant for a **minimum of one year** and complete a sponsor questionnaire about the applicant. At least one (1) sponsor is required to complete a home visit and have personal knowledge of how your (the applicant) dogs are housed. The two (2) required sponsors ***may not reside in the same household nor be a married couple living in separate households.***

**NOTE: Newly accepted members will be on a 12-month probationary period in which they cannot sponsor applicants.**

Your application is available for review by any FBDCA member in good standing. After this period your application will be considered at the next quarterly board meeting, sometime after the 30-day posting ends. Letters and comments submitted by members will be reviewed by the Board prior to voting on your application. You will be notified of the results.
