To Title Your Dog: You must pass two temperament tests, under two different judges to receive your AKC Temperament title. This is a non- competitive event. You do not have to pre-qualify.

There will be a judge’s briefing with course layout before each test.

Conditions of Entry

Incomplete entries or forms without signature and/or payment will not be accepted. Temperament tests are open to all French Bulldogs at least 12 months of age that are individually registered with the AKC, individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, and dogs with AKC Limited or Conditional Registration. Dogs with breed disqualifications and monorchid/cryptorchid dogs are eligible to participate. Bitches in season are eligible to participate as the last dogs of the day to test.
